This mare is booked by name. The booking is valid to the mare named and may not be transferred without consent of the stallion owner. This contract to above mare cannot be sold by mare owner.

No mare shall be bred until stallion contract is returned and breeding fees are paid.

If the mare fails to produce a live foal, return privileges are guaranteed the following year. In the event of death of the booked stallion, a substitute stallion will be provided. No stud fees or stallion semen shipping fees shall be returned for any reason, whatsoever. No blame can be placed on the stallion owner, manager, employees, or other for semen not delivered on time by either airlines or Fed Ex.

Terms and conditions shall be construed and governed by the laws of the State of Illinois and jurisdiction and venue shall be irrevocable in Tazewell County, Illinois.

Neither the stallion owner, manager, farm, nor its members, agents or employees shall be liable for injury, death, or disability suffered by the mare, from any cause whatsoever, while in the custody of Danette Musselman or Queenwood Stables, and the owner specifically assents to such conditions and waives each and every claim for damages resulting from such injury, death, or disability.

All charges including transportation, board, and veterinarian fees, fresh cooled shipment fees, as well as any and all related medicines or medical supplies, etc. are to be paid monthly by the owner of the mare.

The mare owner is responsible for safe and complete return of all equitainers and its contents used during fresh cooled semen shipments. No exceptions. Equitainers must be returned within 2 days of last insemination. A \$350. fee will be charged for all equitainers not returned within this time frame.

The first stallion collection fee of \$250.00 must be paid in full prior to the first semen shipment. All other stallion shipments will be billed out to the mare owner.

The stallion manager reserves the right to reject any mare not in good physical condition. The stallion manager also reserves the right to reject any mare that fails to produce a live foal during two consecutive breeding seasons. The stallion owner also has the right to discontinue business with a veterinarian or farm who fails to get a mare in foal after two shipments of fresh cooled semen. Any dispute or complaints over the quality of fresh cooled transported semen must be made in writing by a licensed veterinarian.
